R.S. 17:3701 et seq. The Athlete Agent shall not represent the Athlete in connection with

any endorsement contract or endorsement activity that the Athlete Agent knows or reasonably should know would cause the Athlete to lose eligibility.

This Disclosure, the Athlete Agent, and any endorsement contract or endorsement activity related to the athlete's NIL matters shall comply with all applicable requirements of La. R.S. 17:3701 et seq. and any rule adopted by the Public Protection Division of the Louisiana Department of Justice (the "Division").

8. Recordkeeping and Statutory Notices

- a. **Retention.** A copy of this Disclosure shall be retained by both the Athlete Agent and the Athlete. This Disclosure is not required to be filed with the Division but shall be produced to the Division upon request or subpoena.
- b. **Forfeiture of compensation.** If the Athlete Agent fails to execute this Disclosure as required by La. R.S. 4:423.1, the Athlete Agent forfeits any right to compensation in connection with any endorsement contract or endorsement activity undertaken by the Athlete.
